INSTRUCTIONS

The fastest, easiest way to file this return and make your payment is using MyDORWAY, our free online tax portal. If you've never created a MyDORWAY account, get started at **dor.sc.gov/MyDORWAY-signup**. Do not mail this form when filing online.

Due date: January 31 of the following year

You must file a return even if you withheld no SC Income Tax during the quarter. You must file a WH-1606 if the account was open for any portion of the calendar year.

Use only fourth quarter amounts for lines 1-6.

- Line 1 Enter total SC Income Tax withheld from all sources **in the fourth quarter**. Enter the corrected amount if filing an amended return.
- Line 2 Enter total SC Income Tax deposits or payments made in the fourth quarter. For amended returns, include the amount paid with original WH-1606.
- Line 3 If line 2 is greater than line 1, enter the amount of SC refund. **SKIP LINES 4-6.**
- Line 4 If line 2 is less than line 1, enter the amount of SC tax due.
- Line 5 Enter the amount of penalty and interest due. Visit **MyDORWAY.dor.sc.gov** for a penalty and interest calculator.
- Line 6 Enter the total SC Income Tax, penalty, and interest due.

Annual amounts. You are required to complete lines 7 through 10. Enter the corrected figures when amending a return.

- Line 7 Enter the amount of SC Income Tax withheld in each quarter and enter the total on line 7.
- Line 8 Enter the total SC Income Tax withheld from all quarters reported from W-2s, W-2Gs, and 1099s. Line 8 should equal the total of all quarters from line 7. If there is a difference, you should review your records to determine the quarter or quarters that should be amended.
- Line 9 Enter the total SC income from all W-2s, W-2Gs, and 1099s.
- Line 10 Enter the total number of wage and tax statements.
 - Submit all W-2s online **or** with a WH-1612.
 - Use the state copy of W-2 forms.
 - \circ Do not submit W-2s with a WH-1612 if you submit online.
 - W-2Gs, W-2cs, 1099-MISCs, 1099-Rs, and 1099-NECs can be submitted online on MyDORWAY; all other 1099s must be submitted using a WH-1612.
 - Only include 1099s with SC tax withheld.

To avoid delays in processing your return:

- Remember, amounts withheld from employees on W-2s cannot be refunded to employers.
- Use black ink only.
- Do not staple attachments.
- Write all numbers clearly. Always include cents. (examples: 20.13, 19.00)
- Do not put slashes, dashes, dollar signs, or commas on the amount lines.
- Sign the return. The signature must be from a person authorized to act on behalf of the Withholding agent.
- Sign your check and include the written dollar amount.
- Attach payment for the full amount due to this return. Do not include a WH-1601 coupon.
- Mail to the correct address.

 - Refunds or zero tax: SCDOR, Withholding, PO Box 125, Columbia, SC 29214-0004

Authorization and signature:

Check the box for release of confidential information and provide your preparer's name and phone number. This authorizes the Director of the SCDOR or delegate to discuss **this** return, its attachments, any notices, adjustments or assessments with the preparer.
