This form provides a list of Sales Tax rates, Accommodations Tax rates, unprepared foods tax rates, and local taxes along with their reporting codes for South Carolina counties and municipalities. Local taxes directly collected by the counties or municipalities are not included.

To qualify as unprepared food, a food item must be able to be lawfully purchased with United States Department of Agriculture food coupons under the state Sales and Use Tax exemption. For an explanation of this exemption, see SC Code Ann. Regs. 117-337, available at dor.sc.gov/policy.

Local tax name abbreviations used on this chart are: **CP** - Capital Projects, **SD** - School District, **ECI** - Education Capital Improvement, **TT** - Transportation Tax, **LO** - Local Option, **TD** - Tourism Development.

*-Indicates a municipality is located in more than one county. To determine the appropriate tax rate for your business, check with your local municipal government.

If your sales or purchases are delivered within the municipal limits of an incorporated city or town, you must use the specific county or municipality code for that location. Otherwise, use the Unincorporated code for that county.

An individual 85 years old or older is entitled to claim a 1% exemption from State Sales & Use Tax on purchases for their own personal use. They must provide proof of age at the time of sale. For more information, see SC Revenue Ruling #16-9, available at dor.sc.gov/policy.
